

## Contest PROFIT SPRINT

### 1. General provisions

- 1.1. TS Basis Ltd. is the organizer of the contest.
- 1.2. Everyone who wishes and comply with contest requirements can take part in the contest.
- 1.3. The staff of TS Basis Ltd and members of their families are not allowed to participate in the contest.
- 1.4. To participate in the contest you must register the contest account and upload a scan of the passport in the Private office. Registration is held only once. After the contest account being registered, you can participate in all tours of the contest. Accounts registered to data different from the data downloaded to your account (or not loaded) might be banned to participate in the contest or disqualified.
- 1.5. Registration for the next week contest is available from 17:00 (terminal time) of Friday current week to 12:00 (terminal time) Monday. Applications received after the end of registration will be carried over to the next tour of the contest.
- 1.6. It is prohibited to register more than one account by one participant, as well as trading with one IP address.
- 1.7. It is prohibited to trade through an anonymous proxy server. At the detection of more than three connections to the account from different IP addresses belonging to different regions, the account will be disqualified.
- 1.8. Prize-money and bonuses are transferred to the winner's account in our company. For the transfer of winnings, allowed accounts, Standard or Micro only.
- 1.9. The participants of the contest agree that all operations performed in the framework of the contest, shall be carried out exclusively with virtual money, no financial claims can't be charged to the organizers of the contest.
- 1.10. Participant of the contest should be guided by these rules, which should be read attentively and accepted. Ignorance of the rules of the competition can't serve as an argument when presenting a claim.

### 2. The holding of the contest

- 2.1. The contest is held every week.
- 2.2. Contest starts on Monday at 12:00 (terminal time) and lasts until 17:00 Friday.

### 3. Trading conditions

- 3.1. Standard-accounts with a balance of 500 USD participate in the contest.
- 3.2. Participants can trade only on Currency pairs available in the trading terminal.
- 3.3. There are no restrictions on the amount of orders that can be opened at the same time.
- 3.4. Trading by the Mega lot is prohibited.



- 3.5. Margin Call Level is 110%. Stop out Level is 100%.  
3.6. Minimal count of trading lots for the period of the contest: 0.  
3.7. Maximum leverage 1:200.

#### 4. Results of the Contest

4.1. The winners of the competition are 5 customers who have received the highest percentage of profits on the account. The prizes are distributed among them:

- 1st place prize: \$5000;
- 2st place prize: \$3000;
- 3st place prize: \$1000;
- 4st place prize: \$500;
- 5st place prize: \$500;

4.1.1. The participant who took the prize-winning place, can no longer take the same place in the next tours of the contests. At the end of the contest the company has the right to disqualify a participant if he took the same place more than once.

4.2. The prize is transferred to the winner's Standard or Micro account. For this it is necessary to submit an application from your Private office to the Financial Department through the **Support section – Create ticket**.

In the header, you must specify:

- the name of the contest,
- the number of the tour,
- the date when it was held,
- the place you got.

Header example:

Contest, 1st tour, 15.08.2016 - 19.08.2016, 1st place.

In the text, you must specify:

- number of your contest account,
- number of your Standard (or Micro) to receive prize funds,
- your full name.

Text example:

Contest account № 1231234, Real Standard № 123123, John Smith.

4.2.1. Prize money is accrued on a real account of the participant within three business days.

4.3. Administration of the contest has the right to disqualify the participant (s) with or without notice:

4.3.1. If any of the rules of the competition is broken.

4.3.2. In case of providing the false contact information (data, name), the account may be disqualified and the prize money (if accrued already) can be withdrawn from the account.

4.4. All the results of the current competition are published on the website of the company. The results published on the site, may not be final and can't serve as a reason for announcement of the winner.

4.5. The final results are summed up within 2 work days after the end of the competition, and are published on a website not later than 4 work days from the moment when the contest ends.

4.6. In case of the fraud the administration of the contest has the right to withdraw the prize money from the account of the participant at any time.

#### 5. Additional Conditions

Administration has the right to:

Disqualify violators without a prior notice and explanation of the reason for the



disqualification, if the violation of the rules of the contest is obvious. Check the statements of winners to see if there is any similar and opposing orders in the statements of other participants, and in case of obvious similarity of the orders or obviously opposing orders of different participants, the administration has the right to decide that the accounts are handled by one person and to disqualify the accounts. Cancel the results of the participant who used non-market quotations in the contest. Conclusion on the discrepancy of the quotations is made by the Company's technical support team.

The Company as well has the right to check real accounts to see if there are similar and opposing orders that were opened for winners of this contest, and in case of obviously similar orders and obviously opposing orders of different participants, the administration has the right to cancel the opposing positions and to withdraw the prize money back.

The Company TS Basis Ltd keeps the right to use any information related to the prize accounts, publish the trading history and provide public access to the account with the investor's password for the advertising purposes or to publish it in any mass media.
