1. General terms

1.1 The promotion is valid from the 18th of August 2016.

1.2 The promoter of the promotion is Vertical Markets (TS Basis LTD).

1.3 The Company reserves the right to change the promotional conditions and a list of features of the bonus.

1.4 The Company reserves the right to cancel bonus at any time.

2. Participants

2.1 Participants can become all the customers of the company, as well as those who will open an account during the promotion period.

2.2 Only verified users can participate in the promotion. For verification, you should upload the scan of your ID to your Private Office. The promoter reserves the right to require additional documents for identification and his residence.

2.3 Types of accounts involved in the promotion: Bonus account (Micro)

2.4 In the account participating in the promotion, the leverage cannot exceed 1:200.

2.5 The employees of the Company and their families can't participate in the promotion.

2.6 The participant should read this terms carefully and follow these rules. Ignorance of rules isn't reason when filing a claim.

2.7 Other promotions of the Company aren't applied to the account participating in this promotion.

2.8 Only a private person can take part in the promotion.

2.9 Deposit, withdrawal and internal transfer on Bonus account are not available.

3. Application for the bonus

3.1 To connect the bonus you must:

- register on the website or be a client of the company

- to open an Bonus account

- send request for the bonus on support@vertical-markets.net with indicating the account number to which the bonus will be accrued.

4. Getting the bonus

4.1 The bonus is credited to the account upon fulfillment of all conditions of the rules.

4.2 Bonus is issued once. Reusing of bonus isn't possible.

4.3 Bonus funds are credited for 7 calendar days.

4.4 After this period the bonus is deducted, open positions are closed.

4.5 After cancellation \$ 100 of bonus funds on the trading account is remains only the profit received 7 days.

4.6 A Micro account can be converted into account of type Standard.

4.6.1 The type of account depends on the amount of profit.

4.6.2 Profit equal \$500 or more converts the account to a Standard account.

4.6.3 Profit less than \$500 remains in the account Micro.

4.7 Leverage the account may not exceed 1:200.

4.8 In order to activate the real account a client should deposit the amount same or higher than the resulting profit on the bonus account during 7 calendar days.

4.9 In the absence of deposit profit is deducted from the account.



4.10 Profit obtained on the bonus account is available for withdrawal after a trading volume on a real account at the rate of 5 lots (500 lots on a Micro account) per \$100 of profit. In the case that the amount of profit is less than \$100 only 5 lots.

4.11 To transfer the bonus money in the property you must submit an application. In the message, specify a subject «\$100 - no deposit bonus transfer of the bonus to property» account number, surname, name. The application should be submitted in free form by e-mail.

4.12 Partial withdrawal of profit is impossible.

4.13 Getting bonus and/or trading in bonus funds on two or more accounts from one IP-address is forbidden.

4.14 On the trading account with the bonus is forbidden to trade through anonymous proxy server. If there is any suspicion of abuse of this bonus promotion, fraud, as well as the detection of forgery or counterfeiting of documents from the participant, the account may be disqualified from the accrued bonus, and the customer may be denied service.

4.15 On the bonus funds is forbidden multidirectional trading. The company reserves the right to cancel the bonus and the part of profits received in trade from the calculation of the ratio of own means of the client to profit received on the bonus account, in case of violation of this paragraph.
